NCACCH is an innovative leader in Aboriginal and Torres Strait Islander healthcare, providing a range of services and programs through the implementation of the very first Brokerage Model for health service delivery. Through this highly successful Brokerage Model, NCACCH maintains contracts with over 800 primary and allied health professionals across the region.

With the purpose of providing a holistic and comprehensive primary health care service, NCACCH seeks to improve health and social outcomes to our community through.

Purpose of the Position

Reporting to the NCACCH Chief Executive Officer, you will be responsible for the development and establishment of the NCACCH Aboriginal Medical Service in Gympie.

In particular, this position is responsible for leading a new clinical service development, contribute to ongoing development of clinical policies and standards and working closely with a project team to ensure local clinic systems and workforce are implemented to deliver on targets within the NCACCH model of care.

The Project/Practice Manager operates with the highest level of integrity, accountability, and professionalism in accordance with NCACCHs values and Code of Conduct. In addition, they work towards ensuring the efficiency and effectiveness of program and service delivery and support continuous improvement through encouraging innovation and best practice, within NCACCHs current quality management systems.

Role Responsibilities:

- Oversee the establishment of a new primary health care clinic in response to regionally identified needs
- Oversee the coordination of capital works/infrastructure and operational planning to ensure that clinic set-up proceeds smoothly, efficiently and within allocated timeframes
- Provide practice management of the new clinic during the set up phase and in the early stages of clinic operation, establishing resources, processes and systems in line with the NCACCH model of care
- Provide training, development and mentorship for new clinic team during an agreed period of new clinic handover
- Establish and develop new clinical service development, support the development of drafting policies and procedures and provide assistance to the clinic team in the smooth integration of specialised and primary care services
- Demonstrate leadership of a professional team that provides the highest standard of client care
- Develop productive working relationships with local community networks, service providers and suppliers to market and encourage cross-functional collaboration with the new NCACCH Aboriginal Medical Service
- Undertake reporting activities with other relevant documentation within the scope of the role
