About QAIHC

The Queensland Aboriginal and Islander Health Council (QAIHC) is a leadership and policy organisation. We were established in 1990 and are the peak organisation representing our membership of Aboriginal and Torres Strait Islander Community Controlled Health Organisations (ATSICCHOs) located throughout Queensland. Nationally, we represent Queensland through our affiliation and membership on the board of the National Aboriginal Community Controlled Health Organisation (NACCHO).

Artwork concept

Your artwork will respond to the themes we are passionate about. These include:

- Achieving health equity for Aboriginal and Torres Strait Islander Queenslanders
- The importance of self-determination and an Indigenous voice in the funding and provision of health services
- The central role of community-led and community-controlled health services
- Closing the Gap for Aboriginal and Torres Strait Islander peoples across all areas, especially those impacting health, living conditions and workforce opportunities.

Your artwork can be symbolic, abstract or figurative in any painted or drawing media. We would love to see something that is bright and colourful and strongly encourage you to make use of our corporate colours in your artwork (see colour palettes below). Ideally your artwork will be in a portrait format and be approximately 600mm (wide) x 900mm (high) in size.

In making our final selection we will be taking into consideration, and giving preference to, works that can be digitised and/or contain graphic elements that can be extracted for separate use throughout our corporate brand.





The successful artist/s will receive \$1500 plus GST for their artwork. \$500 will be payable to the artist on acceptance of the design, with the remaining funds payable upon delivery of the final artwork.
